INVITATION FOR BIDS

Sealed proposals for the improvements described below will be received at the offices of the Ela Township Highway Department, 23605 N. Echo Lake Road, Lake Zurich, Illinois (847.438.2371), until 10:00 A.M. Thursday, October 18th, 2018. All bids will be publicly opened at that time and read aloud. The bid must be held open for 45 days from the date of bid opening. Specifications, Plans, and Contract Documents may be obtained at the Ela Township Highway Department, 23605 N. Echo Lake Road, Lake Zurich, IL (847-438-2371), beginning October 2, 2018. A non-reundable deposit of \$50.00 is required for each set.

Separate, sealed opaque envelopes or packages containing each bid shall be transmitted to the attention of the Highway Commissioner and shall be marked or endorsed with the title of the bid ("Ela Township Highway Department- 2018 Marilyn Lane Drainage Improvements") and the Bidder's full legal name. All bids for the Work shall be made only on the blank Bid Form included in the Specifications and Contract Book and shall be complete with a bid unit price for each and every item named in the Schedule of Prices section of the Bid Form. An authorized agent must sign the bid. Bids that contain omissions, erasures, alterations, or additions not called for, conditional or alternate bids unless called for, or that contain irregularities of any kind may be rejected.

Subcontracting portions of the work will be allowed pursuant to Section 108.01 of the "Standard Specifications for Road and Bridge Construction", Illinois Department of Transportation, latest edition. The Owner reserves the right to reject any bidder or subcontractor who, in the opinion of the Owner or the Engineer, does not have adequate experience, personnel or equipment to perform the work in a timely, efficient and satisfactory manner.

The Owner reserves the right to reject any and all bids or any part thereof and waive any informality or any irregularities or defects in any or all proposals and to accept that bid which in its opinion is in the best interest of the Owner. Any such decision shall be considered final. It is the intent of the Owner to award a contract to the lowest responsible, responsive bidder.

The work is located within Hillside Estates Subdivision in unincorporated Ela Township, Lake County, IL. The work for which proposals are invited will consist of, in general, but shall not be limited to, the following: storm sewer removal and replacement, landscape restoration and all other incidental work necessary to complete the project.

Bid security in the form of a Bid Bond for five percent (5%) of the total bid made payable to the Ela Township Highway Department shall accompany the bid.

The work shall be prosecuted in such a manner and with such a supply of materials, equipment and labor as is considered necessary to ensure its completion according to the time specified in the Contract. The Contractor shall be completed on or before Friday, December 14, 2018, as described in Article 108.05 of the Standard Specifications. In case of failure to complete the work on time, the provisions of Article 108.09 of the Standard Specifications.
