Staff is also requesting the authorization of an \$800 one time setup fee and a \$1,200 annual cloud hosting fee not to exceed a total of#2,000 for services provided from I.T. Right. Additionally, staff is requesting to enter into a software maintenance and support agreement with BS&A Software in the amount of \$2,360 for second year due in the 2019/early 2020. All expenses will be paid from funds budgeted under General Town and General Road funds.
