I, the undersigned, acknowledge that parking is a privilege and not a right. I agree to abide by all the rules set forth in the Knigge Park Parking Lot Ordinance and certify that I have reviewed the Ordinance. In addition, I agree to the following rules:

1. Parking permits must be displayed in the lower portion of the passenger side front windshield of permitted vehicle.
2. **Permits are not transferable to other students or vehicles.**
3. The award of a parking permit by Ela Township is a matter of discretion on the part of Ela Township and creates no property right in the person to whom the permit is issued.
4. Students who have been issued parking permits by Ela Township for the current school year shall be permitted to park vehicles displaying valid permits at the Knigge Field parking lot between the hours of 6:00 A.M. and 3:30 P.M. **also allowing for late after school extra curricular functions Monday through Friday during the school year.**
5. If a permitted vehicle is sold or becomes inoperable, the student must notify the Ela Township Highway Department, which may issue a replacement parking permit to the permit holder. **There is a \$25.00 fee for a replacement sticker.**
6. Each parking permit will pertain to an assigned parking space. Each vehicle may only be parked in the designated space.
7. Knigge Field parking lot parking permits remain the property of Ela Township and must be surrendered upon request.
8. Ela Township reserves the right to recall or revoke permits for any reason or no reason at all, to deny permits, to suspend permits, to close the parking lot and deny entrance to permit holders and to change this policy.
9. Vehicles parked in the parking lot which do not bear a valid sticker in the proper location or which are parked in the wrong location will be towed at the car owner's expense.
10. Permit holders operating vehicles in the lot shall possess a valid Illinois driver's license and the required insurance for the vehicle.
11. Permit holders entering and exiting the Knigge Field parking lot shall obey all speed limits and traffic laws.
12. Permit holders shall not deposit paper, garbage, food, beverages or debris in the parking lot or on any Township property.
13. Permit holders shall not loiter in the Knigge Field parking lot.
14. I agree to execute the Waiver and Release of all Claims related to Ela Townships parking program.
15. Permit holder is responsible for any rule violation made by passengers in their vehicle.
16. Speeding in and/or around parking lot will not be tolerated.
17. Students who abuse the rules will receive one verbal notice. Continued actions will result in the parking sticker being revoked.
18. Signs are installed by Alpine Automotive which will have the right to tow cars. The students will be held responsible for all fees incurred.
19. **Keep off the grass – use the walkway.**

Beginning school year 2018-2019 – a full refund will be awarded if you do not occupy the space within 10 day of the start of school. Once the parking space has been occupied for more than 10 to 30 days, a refund will be processed for \$100.00 less than total paid for space. After 30 days there will be no refund given.

I further understand and certify that Ela Township reserves the right to recall, revoke, or suspend my permit for a violation of Ordinance No. 2005-09, to prosecute ordinance violations. I further understand that the Township reserves any and all other rights it may possess by law to enforce property regulations regarding Knigge Park.

**IMPORTANT INFORMATION**

Ela Township is committed to operating its property in the safest manner possible and holds the safety of its Constituents in the highest possible regard. Participants in the parking program and parents authorizing their child(ren) for parking permits must recognize, however, that there can be an inherent risk of injury involving minor drivers. Ela Township continually strives to reduce such risks and insists that all users of Township property follow safety rules and instructions which have been designed to protect the users = safety.

Please recognize that Ela Township does not carry medical accident insurance for injuries for users of Township property. The cost of such would make the Township fees prohibitive. Therefore, each person applying for a parking permit should review their own health insurance policy for coverage. The absence of health insurance coverage does not make the Township automatically responsible for the payment of medical expenses. Due to the difficulty and high cost of obtaining liability insurance, the agency providing liability coverage for Ela Township requires the execution of the following waiver and release. Thank you for your cooperation.

**WAIVER AND RELEASE OF ALL CLAIMS**

Please read this form carefully and be aware in registering your child or ward for participation in the Knigge Park parking permit program you will be waiving and releasing all claims for injuries you or your minor child/ward might sustain arising out of the program.

As a parent/guardian of a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, (including death), damages or loss which I or my minor child/ward may sustain as a result of participating in any and all activities connected with or associated with such parking program.

I agree to waive and relinquish all claims I or my minor child/ward may have as a result of participating in the program against Ela Township and its officers, agents, servants and employees.

I do hereby fully release and discharge Ela Township and its officers, agents, servants, and employees from any and all claims from injuries, (including death), damage or loss which I or my minor child/ward may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with the activities of the parking program.

I further agree to indemnify and hold harmless and defend Ela Township and its officers, agents, servants and employees from any and all claims resulting from injuries, (including death), damages and losses sustained by me or my minor child arising out of, connected with, or in any way associated with the activities of the parking program.

In the event of any emergency, I authorize Ela Township officials to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for my minor child=s immediate care and agree that I will be responsible for the payment of any and all medical services rendered.

I have read and fully understand the above document, waiver and release of all claims and permission to secure treatment.
