## ***RESOLUTION 2016-05***

### **RESOLUTION SETTING COMPENSATION OF TOWNSHIP OFFICIALS FOR THE FOUR YEAR TERM STARTING MAY 15, 2017 AND ENDING ON MAY 17, 2021 ELA TOWNSHIP, LAKE COUNTY, ILLINOIS**

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the term of office.

**NOW, THEREFORE, BE IT RESOLVED** by the Ela Township Board that compensation of the Elected Officials for the term May 15, 2017 to May 17, 2021 is set in accordance with Illinois State law and as follows:

#### **SECTION 1: Salaries of Elected Officials**

##### **A. Supervisor**

**SECTION 2: Insurance, Retirement/Pension and other benefits**

(1) The Supervisor position is considered part time, working an average of 15-20 hours per week. The Highway Commissioner position is considered part time working an average of 32 hours per week in year one, 30 hours per week in year two, 25 hours per week in year 3 and 18 hours per week in year four. The Assessor position is considered full time, working an average of 40 hours per week. The Clerk’s position is considered part time, working 10-15 hours per week.

Assessor position is eligible and required to participate in the Illinois Municipal Retirement Fund (IMRF). The Highway Commissioner position is eligible and required to participate in the Illinois Municipal Retirement Fund (IMRF) for years one to three of term.

(2) Such medical insurance coverage or benefits as may be provided from time to time by the Township Board to the employees shall be made available to the Assessor for full term and Highway Commissioner for years one & two of term at the same cost to the official as charged to the employee.

(3) A telephone is made available to the Supervisor, Assessor, Clerk and Highway Commissioner.

(4) A Township truck is made available to the Highway Commissioner.

(5) An annual clothing allowance as provided to Highway Dept employees shall be given to the Highway Commissioner
