ORDINANCE No. 2016-07

An ordinance levying taxes for all town purposes for <u>ELA</u> Township,
LAKE County, Illinois, for the tax year 2016, collectable in 2017.
BE IT ORDAINED by the Board of Trustees of <u>ELA</u> Township, LAKE County, Illinois, as follows:
SECTION 1: That the sum of <u>TWO MILLION, TWO HUNDRED & FIFTY THOUSAND,</u>
